

WINTERFELL GPWIN 3:1 promotional Campaign

Any dispute arising out of or in connection with these Terms and Conditions, including any question regarding the existence, validity or termination of these Terms and Conditions, shall be referred to and finally resolved by arbitration under the LCIA Rules, which Rules are deemed to be incorporated by reference into this Paragraph. The number of arbitrators shall be three. The seat, or legal place, of arbitration shall be London, UK. The language to be used in the arbitral proceedings shall be English. The governing law of these Terms and Conditions shall be English law. **Referral's Code of Conduct:** Referral's agree that they will not violate any of these Terms, or otherwise engage in activity that could be considered harassment. Referral's agree not to use the Program to: Violate the intellectual property rights of Winterfell, GPWIN and/or the GPWIN Case. Engage in any actions that are designed to disrupt or undermine the Campaign. Transmit files that contain bots, viruses, works, Trojan horses, or any other file that could contaminate or otherwise destroy Winterfell intellectual property or stop the function of the Winterfell GPWIN and/or the GPWIN Case. Engage in illegal or unsportsmanlike activities Engage in behavior designed to annoy or harass others. Severability - Should any part of these Terms and Conditions be rendered or declared invalid by a court or arbitration panel of competent jurisdiction, such invalidation of such part or portion of these Terms and Conditions should not invalidate the remaining portions thereof and they shall remain in full force and effect. Third Party Rights - The Parties do not intend any third party to have the right to enforce any provision of these Terms and Conditions under the Contracts (Rights of Third Parties) Act 1999. Successors - These Terms and Conditions shall be binding on and inure for the benefit of the successors and permitted assigns of the Parties in accordance with these Terms and Conditions. **Reservations of Rights:** We reserve the right to modify or amend at any time these Terms and Conditions and the methods through which Sales Commissions are earned. We reserve the right to disqualify any Referral at any time from participation in the Program if he/she does not comply with any of these Terms.
